



# **Know Your Numbers**

Complete your biometric screening



All employees, spouses, adult dependents and retirees enrolled in medical insurance with Partners for Health can complete a biometric screening.

When you know your numbers, you'll be able to see where your health stands today and where you can make improvements for a healthier future. Plus, if you complete your screening from Jan. 1, 2025 - Nov. 30, 2025, you can earn up to \$200!\*

## Options to screen:

At an Event — Attend a screening at or near your work, if available.

Visit a Patient Service Center — Quest Diagnostics has 2,200 convenient PSC locations across the country.

Download a Physician Results Form\*\*

— Download this form through Quest
Diagnostics and bring to your doctor to
fill out all your health numbers from a
recent physical. Return the form via fax
or upload through the Quest site.

Order an At-Home Kit\*\*\* — If you feel more comfortable staying home, request self-collection materials to complete your screening.

All screenings must be completed from Jan. 1, 2025 - Nov. 30, 2025.

# To sign up:

Visit stateoftn.sharecare.com.

- 1. Select **Achieve**, **Programs** and **Health Screening**.
- 2. You will then be directed to the Quest Diagnostics Health & Wellness site to schedule and/or alter your PSC or onsite appointment, request an at-home kit, or download/upload your Physician Results Form.

Biometrics may also be accessed through your Sharecare account via the Benefits Hub.

#### Be ready for the screening:

- Drink a lot of water.
- Keep taking your medications, as prescribed, the day of your screening.
- Show up a few minutes before your scheduled time.

### **Incentives:**

Employees and spouses, complete your screening by Nov. 30, 2025 to earn \$50. If three out of four biometric screening lab values are in-range, you will earn \$125. If your blood pressure targets are also in-range, you will earn an additional \$25.\*

**Note:** You must complete the **RealAge Test** to earn your incentives. Once logged into your account, visit **You > Your RealAge** to get started.

\*\*If you complete a biometric screening with your doctor anytime between Dec. 1, 2024 - Nov. 30, 2025, these lab results can count toward your 2025 incentive earnings. You have until Dec. 15, 2025, to submit a Physician Results Form.

\*\*\*Please note: Your at-home test kit must be ordered and returned in the same program year. If you order an at-home kit and do not return it within the same year, you will no longer see it as an option to complete your biometric screening in subsequent program years.
